Nominees must be current members of the Recreation and Parks Association of Nunavut.

#### **Information Regarding the Role and Responsibility of a Director on the Recreation and Parks and Association of Nunavut Board of Directors:**

##### Board Meetings

Up to eight (6) meetings are held throughout the course of the year. Meetings will be held bimonthly on the second (2nd) Thursday of each month, starting in September through to June. A meeting time will be scheduled with the Board of Directors following the AGM and elections.

##### Board Development

When opportunity exists, the RPAN Board of Directors shall meet for an in person planning meeting and Board Development exercise.

##### Sub Committees

In addition to the above, Board members may sit on a Sub Committee.
